## Warranty Policy

The Government is offered the following Commercial Warranty supplemented with the Government's warranty clauses 52.212-4 (o) and 52.212-4 (p) (TAILORED).

**Commercial Warranty** – AOTI warrants that as of the date of shipment and thereafter until the earlier of: (i) 18 months or (ii) 12 months from the date the AOTI Product is shipped to a customer or sub-distributor by Advanced Oxygen Therapy, Inc., the Products will be free of defects, whether latent or otherwise, in materials and workmanship. AOTI will repair or replace (at AOTI's sole option and expense) any defects, which may develop within the warranty period. This warranty does not extend to expendable items such as membranes, hoses, and filters, which are warranted to be free from defects only at the time of the original delivery, nor does it extend to Accessories. AOTI shall pass through to CUSTOMER all applicable manufacturer warranties for Accessories. AOTI further warrants that the Products will (a) conform to all Specifications, drawings, plans, or other descriptions furnished by AOTI; (b) be new and merchantable; and (c) be free of any claim of any nature by any third person. AOTI warrants that all replacements or repairs undertaken by it will be free from defects in material and workmanship under normal use and service for a period of 90 days from the date of return shipment to the end customer or until the end of the original warranty period, whichever is greater. These express warranties specifically exclude defects in AOTI Product that are (1) caused by the use or operation of AOTI Products in any application or environment other than that intended or recommended by AOTI, (2) caused by unauthorized modifications or alterations made to AOTI Products by CUSTOMER or any third party, (3) caused to Product when AOTI's preventative maintenance policy was not kept in full (4) caused by unauthorized maintenance performed on AOTI Products by untrained CUSTOMER personnel or by any third Party, or (5) caused by fire, unusual dampness, willful or accidental damage, improper use or care, unusual physical or electrical stress or other causes beyond the control of AOTI. Except for the express limited warranties or conditions in this Exhibit, AOTI makes no warranties on AOTI Products, express, implied, or statutory, and AOTI specifically disclaims any implied warranty or condition or merchantability or fitness for a particular purpose. In breach of warranty action AOTI shall not be liable for any damages, including loss of profits, or incidental or consequential damages, arising out of the use, or inability to use AOTI Products.

**Government warranty clauses 52.212-4 (o) and 52.212-4 (p) (TAILORED):**

Warranty: The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract. In the event that the terms of the contractor's standard commercial warranty conflict with the warranty terms contained in this clause, the terms of this clause will govern this contract, unless some other resolution is specified in the award document. Limitation of liability: Except as otherwise provided by an express warranty, the contractor will not be liable to the Government in a breach of warranty action for consequential damages resulting from any defect or deficiencies in accepted items. In the event that the terms of the contractor's standard commercial warranty/limitation of liability clause(s) place greater limits on the contractor's liability than do the terms contained in this clause, the terms of this clause will govern the contract.

## **Returned Goods Policy**

The Government is offered the following Commercial Return Goods Policy (RGP) supplemented with the Government Return/Exchange Goods Policy which includes a shipping error statement plus no restocking fee:

**Commercial Return Goods Policy:** Prior to return of Product for repair, customer shall contact AOTI's Service Center to request a return goods authorization from AOTI. Upon receiving such request, AOTI will provide customer with a Return Material Authorization (RMA) number to be prominently displayed on the shipping container for the defective product. Once AOTI authorizes the return of defective Product, customer shall ship such Product to the AOTI Repair Facility, in its original container or in a replacement container provided by AOTI, or in a container that meets specifications that AOTI shall supply customer and AOTI undertake that the Product shall be shipped by a carrier experienced in handling sensitive freight and that Product returned by customer for repair or replacement must include a report indicating the type of failure. AOTI shall promptly, within a reasonable time, return repaired Products. AOTI shall ship the repaired or replaced Product to customer, freight and insurance expenses prepaid by AOTI. New and un-used Products will be replaced by new Parts and/or Products.

**Return/Exchange Goods Policy:** If a shipping error occurs due to AOTI Inc error, AOTI Inc will pay freight both ways for return/exchange of products. If an ordering facility error occurs, the ordering facility will pay return freight. No restocking fee will apply either way.
